President's Message



How Is Dallas Doing It?

That's the question I keep getting asked when I travel to other large departments.

They want to know what the secret recipe is. How are you getting your officers to not just show up to work but to proactively police again? The answer is not some great secret, it's not something that was created by a "new way of thinking." Nope. It's a practice that has been used before and has worked time and time again. Departments have just not been willing to put themselves out there and do the right thing.

What is the magic trick? It's the simple recipe of supporting your officers and not selling them out just because the activists are yelling, or the water gets a little hot in City Hall. It's showing your officers that you're willing to get your boots dirty and do the same dangerous work you are asking them to do for the city to be safer. It's not you asking them, "what can I do to make your job easier?" or you responding to their questions with the stale old City of Dallas answer of "that's out of my control" or "because we always have done it that way." Officers want to hear their leaders stand up and say, "I'm the Chief or a Chief and I have the authority to do this and make this change so I'm doing it." The leader is doing it because his/her troops are asking for it to make their job safer and easier. You're doing because they work for you, and you work for them. The troops work to keep the citizens of Dallas safe, and leadership works to keep the troops safe.

Another aspect that has worked in Dallas is the idea of if you say you're going to do something keep your word and do it. The "status quo" is not good enough anymore, and we can't keep asking more from less and allow or expect officers to let their family life suffer for the prosperity of the city. It's not right to ask that from the people who risk so much for this city. Crime has reduced in this city because we have combined the new with the old. We have looked back at

our police history and took the good things that used to bring communities together with police and added the new style of policing to be more effective and efficient. We had the arguments during the Chief Brown era when the department attempted to replace human bodies with computers and technology to save money and be more efficient. What we could not get them to understand is that computers can't place handcuffs on anyone. Computers cannot patrol neighborhoods and build trusting relationships that come from people who display courage, compassion and empathy.

As I have answered those questions on how "we" are getting it done, I look back on where we were and the complete mismanagement of the department and its lack of realizing its most valuable asset: its people. The department fell into the trap of believing that they could discipline their way to positive results, not understanding that that style only brings you disenfranchised and resentful employees. People work because they feel valued and believe in a business or product. The officers of the Dallas Police Department feel they are valued because they are being paid a fair wage and their voices are being heard by those that lead them. This is the recipe that works. Positive policing starts from the bottom up but accountability, leadership and integrity starts from the top down. That's the small print on the employer-employee contract that people forget to read or ignore.

That's how Dallas is doing it.







Officer Profile: The Viral Green Giant of Northeast

We have all been there. You clear your latest call then immediately hear the tone on the radio. A little part of you dies inside when the dispatcher sends you to a major accident on the freeway involving a tractor trailer.

You are busy reminding yourself to get the license plate of the trailer and the cab, then arrive at the scene only to see Johnny Green waving at you. He is already working the accident. The sun shines a little brighter, the birds sing a little prettier, and you exhale and begin working on the wrecker sheets for the accident.

That has been a common occurrence for Northeast officers for the past 14 years. Standing 6'4" and muscled up 330 pounds, Johnny Green #9358 is one of the most physically imposing officers in the department. He has been married for 24 years and has a son and three daughters. He also happens to enjoy doing accident reports. Green has completed over 1,200 accident reports in the CRASH system, and he approves accident reports for Northeast officers on second watch.

Green is serving the community he grew up in. He graduated from Bryan Adams High School in the Northeast Division. He then served his country by spending four years in the United States Marine Corps.

Green's favorite part of the job is the friendships he has built with other officers. "Just the camaraderie with the guys. It reminds me of when I was in the military," Green said. He enjoys working accidents because it allows him to interact with members of the community that police do not typically see. "I feel like you actually help people when you work a crash," Green said. "We do not typically have a lot of contact with the good citizens who are going to work. When you go over there and help them, they genuinely are happy with our service after we finish the call, unlike a lot of calls we go to."

Green is an avid weightlifter, who started working out when he was sixteen to help channel the anger he felt when his father passed away. He continued lifting while in the military and during his police career. He has worked his way into becoming one of the strongest police officers in America. "I just love the progression of getting stronger and stronger, and seeing how your body adapts to that," Green said. That progression has led to some eye-popping results.

Green's personal best lifts include 675 pounds on the squat, a 700-pound deadlift, 600 on bench press, and 405 on overhead press. He currently has the highest verified bench press listed on the wall at the elite Destination Dallas Gym at 585 pounds.

His one-rep max lifts are impressive, but what really sets Green apart from others is the number of reps he can do with heavy weights. Green has bench pressed 500 pounds for seven reps. He has done 17 reps of 405 pounds raw, without any wraps or bench shirt on. He has done two reps of 405 on seated military press. While he is most proud of his overhead lift max of 405, his favorite lift is the bench press. "I like the bench because everyone can relate to it. At one time or another, whether it be in sports or elsewhere, almost everyone has tried the bench press," Green said. "Everyone knows how much they did and can measure themselves against each

other by that lift.”

Green began making videos of his son, Johnny Mack Green, when he was a starting offensive lineman on the 2017 state champion Allen High School football team. He edited the videos to make highlights and to motivate him in football and wrestling. It worked; his son won the heavyweight state title in wrestling in 2019. He now wrestles in college at Oachita Baptist University.

Johnny Green began making videos of his own after his answers were met with skepticism when random strangers walked up at Quick Trip and asked how much he could lift.

When his son began to post some of those edited videos on the social media site TikTok, Green instantly went viral. Posted on the account @jmack7109, videos of Green’s feats of strength have routinely exceeded one million views. The video of Green repping out 500 pounds on the incline bench has been viewed over 10 million times. His latest video that includes him doing military press with 160-pound dumbbells has generated over 9 million views. The account has over 140,000 followers and has received over 5 million likes.

His imposing stature and incredible strength

bely an extremely humble personality complete with an easy laugh. Green said that his upbringing in Dallas molded him into the person he is today. “Being from here in the 220s and going to schools that were not the greatest, then being in the Marines, that will humble anyone,” Green said. “Living down here, I dealt with a lot of bullies, and I did not like that. A lot of times people who are big have that stigma of being a bully. I hated bullies so I never wanted to come off as one.”

In addition to his weightlifting exploits and viral videos, Green is also one of the top marksmen in the department. The 14-year veteran has been to Top Gun four times.

Green’s partner of 10 years, Michael Waldroup #9222 said that Green’s best attribute is his kind heart. “People see this big and strong guy who works out all the time, and they do not realize he has such a good heart. He is basically a big teddy bear.”
